



IMPORTANT NOTICE – These terms and conditions directly affect your rights, obligations, and remedies as an end-user of Planar products. Please read and understand your rights. Use of the Planar product shall be considered acceptance of this warranty.

Planar PJ17 Customer First™ 1-Year Warranty

Planar's PJ17 product features a 1-year warranty including a 1-year 2-Day Advance Replacement and a 1-year parts and labor, limited-warranty within the United States of America.

Warranty Coverage

Planar warrants its products to be free from defects in material and workmanship during the warranty period. If a Product proves to be defective in material or workmanship during the warranty period, Planar will, at its sole option, repair or replace the Product with a similar new or refurbished Product or refund the lesser of a prorata share, as determined by the remainder of the warranty period, of the then current market price or the depreciated value of the product based on the purchase price if repair or replacement is not commercially feasible.

Length of Warranty

Planar's PJ17 product is warranted for 1-year replacement including 1-year parts and 1-years labor. Warranty begins upon date of shipment of the Product. Warranty valid for the PJ17 product.

Who the Warranty Protects

This warranty is valid only for the first consumer purchaser.

Warranty Exclusions

The following conditions or circumstances are not covered under the terms of Planar's warranty:

1. Planar is unable to deliver to PO Box, APO Box and FPO Box addresses.
2. Any product, on which the serial number has been defaced, modified or removed.
3. Rental costs incurred by Customer in the event of Product failure.
- 4 Damage, deterioration or malfunction resulting from:
 - A. Accident, misuse, neglect, improper ventilation, fire, water, disaster, lightning, or other acts of nature, smoke exposure (cigarette or otherwise), unauthorized product modification (including use of an unauthorized mount), or failure to follow instructions supplied with the product.
 - B. Repair or attempted repair by anyone not authorized by Planar.
 - C. Any damage of the product due to shipment.
 - D. Removal or installation of the product.
 - E. Causes external to the product, such as electric power fluctuations or failure.
 - F. Use of supplies or parts not meeting Planar's specifications.
 - G. Normal wear and tear
 - H. Customer caused defects, including but not limited to: cracked LCD, scratched LCD, blemished LCD (dark spot larger than 1/16 inch), or scratched/defaced/altered plastics.
 - I. Failure to follow maintenance procedures as outlined in the Product's user guide where a schedule is specified for regular cleaning of the Product.
 - J. Opening the Product and/or tampering with internal circuitry.
 - K. Products lost, stolen or discarded by Customer.



- L. Any other cause, which does not relate to a Product defect.
- 5. Removal, installation, and set-up service charges.
- 6. Any Planar display product used as a component in another different Planar product.
- 7. A valid credit card is required to obtain 2-Day Advance Replacement service within the United States. If the Customer is unable to provide a valid credit card, Planar will provide Return and Repair service.

Miscellaneous Return Issues

- 1. Planar will not accept a returned Product unless an RMA number has been previously issued by Planar.
- 2. If the defective Product is returned and deemed to be covered by one of the warranty exclusions, Planar reserves the right to charge the Customer credit card an amount not to exceed the MSRP.
- 3. If Product is returned and is deemed to be a No Fault Found (NFF) unit, Planar reserves the right to charge Customer's credit card for \$95.00.
- 4. It is the responsibility of the Customer to properly package the defective Product and ship it to the address provided by the Customer Service representative with the RMA number prominently displayed. If the defective Product is not properly packaged by the Customer and is damaged in transit during its return to Planar, depending on method used, the Customer's credit card may be charged for either the repair costs, if repairable, or the MSRP of a replacement Product.
- 5. The replacement Product will assume the remainder of your original Product's warranty or 90 days, whichever is longer.
- 6. Replacement accessories will assume the remainder of the original 90 day warranty or 30 days, whichever is longer.
- 7. The Customer agrees to retain the replacement Product and that the Customer's defective Product becomes the property of Planar. Warranty Outside the United States of America

Products in these locations receive the same terms in the Warranty Coverage, Length of Warranty, Who the Warranty Protects, Warranty Exclusions, and Miscellaneous Return Issues sections as outlined above for the United States with the following exceptions:

- 1. Advance Replacement is not available.
- 2. Return and Repair/Replace is the applicable warranty process.
- 3. Customer is responsible for paying freight charges to ship the defective Product to an authorized Planar repair depot/dealer/distributor.
- 4. Customer is responsible for paying freight charges to return the repaired/replaced Product from Planar to the Customer location.

Customer First™ Replacement Guidelines

Contact Planar's customer service (toll free) at 1-866-PLANAR-1 (1-866-752-6271). The customer must have the model number, serial number and original proof-of-purchase available. Planar's customer-service staff will attempt to correct any minor issues that might be causing the problem. If we are unable



to resolve the problem through troubleshooting, a return material authorization (RMA) number will be issued.

If it is within the 1-year warranty period, Planar will ship the Customer a 2-Day Advance Replacement Product. A valid credit card is required to obtain the 2-Day Advance Replacement service within the United States. If the Customer is unable or unwilling to provide a valid credit card, Planar will provide Return and Replace or Return and Repair service, as Planar deems appropriate to the circumstances.

After receiving the replacement unit, the customer will have 14 calendar days from the date of shipment of the replacement unit, to return the defective, authorized RMA unit to the Planar authorized return facility.

1. Return the defective Product in the box in which the 2-Day Advance Replacement Product was shipped.
2. Attach the prepaid RMA return label, included with the 2-Day Advance Replacement Product. Verify that the serial number on the RMA return label matches the serial number of the defective Product being returned.
3. Call the shipping pick-up number provided with the 2-Day Advance Replacement Product for package pick-up, or drop it at the local UPS location. For door-to-door pickup, UPS may charge a pickup fee for which Customer is responsible. If another carrier is used other than the prescribed carrier, the Customer is responsible for the shipping cost incurred when returning the defective Product.
4. All defective Product returns are to be sent by ground transportation. Customer is responsible for excess charges for any other method of return.
5. In the event that steps to return the defective Product described above are not followed, Planar reserves the right to charge the Customer's credit card the full MSRP. If Planar receives the defective Product within the 14-calendar day timeframe, in good condition, the Customer's credit card will not be charged. If the defective Product is received beyond the 14-day timeframe, the Customer's credit card will be charged an amount equal to the current MSRP of the Product

PLANAR'S LIABILITY IS LIMITED TO THE COST OF ONE OF THE FOLLOWING REMEDIES: (1) REPLACEMENT WITH A SIMILAR NEW OR REFURBISHED PRODUCT; (2) REPAIR OF THE DEFECTIVE PRODUCT; OR (3) REFUND OF A PRORATA SHARE OF THE CURRENT MSRP AS DETERMINED BY THE REMAINDER OF THE WARRANTY PERIOD IF REPAIR OR REPLACEMENT OF THE PRODUCT IS NOT COMMERCIALY FEASIBLE. THE REMEDY CHOSEN WILL BE IN GOOD FAITH AND AT THE DISCRETION OF PLANAR. PLANAR SHALL NOT BE LIABLE FOR:



1.
